# Minutes Annual Congregational Meeting Grace United Church Sunday, February 10, 2013

- Opening Prayer Brad Morrison
- 2. The meeting was officially opened and duly constituted by Gord Walkling at 12:15 pm.

Motion: That adherents be allowed to vote on all temporal matters (as per Manual 113).

John Cooke/John Robertson. Carried.

3. Approval of the Agenda

Motion: That the Agenda for the February 9, 2013 Annual Congregational Meeting be approved.

John Robertson/Marie Nicolson. Carried.

4. Approval of the Minutes of Congregational Meetings

Motion: That the Minutes of the Congregational Meeting held on Sunday, March 4, 2012 be approved.

George Vero/Ellen Robertson. Carried.

5. Review and Approval of 2012 Reports

The Congregational Care & Growth Report was corrected to read "the 2013 members will be", rather than "the 2012 members will be."

Motion: That the reports of Council, Committees & Groups be accepted, as printed in the 2012 Annual Report (with the above correction), excluding the reports of the Finance and Nominating Committees.

John Robertson/Trevor Jordan. Carried.

- 6. Finance Committee Report
  - a) 2012 Financial Report

The significant increase in the Ministry & Personnel budget was questioned. Bob Newman, Treasurer, and John Cooke, Ministry & Personnel representative, explained the increase was caused by a combination of the regular cost of living increase, and changes to the employer portion of the pension payments. Together, they represent an increase of approximately five percent (5%).

Motion: That the 2012 Financial Report be accepted as printed in the 2012 Annual Report.

George Vero/Wayne Pease. Carried.

b) 2013 Budget Proposal
 Gord Walkling and Bob Newman presented the 2013 Budget
 Proposal. Concern was raised regarding the low *Designated M & S*

Givings number. It was clarified that in 2012 the offering envelopes were changed to remove the extra givings line for the Mission & Service Fund. This has shifted givings from Designated M & S Givings to Givings for Operating Budget. Also, the budgeted givings to the Mission & Service Fund is found under the section, Committee Expenditures, and for 2013 is set at twenty eight thousand, two hundred dollars (\$28,200). Further, additional givings to the Mission & Service Fund are generated by special events, such as soup luncheons.

Gord Walkling described Council's plan to manage the deficit budget. He explained that our membership has remained level, but is engaged. Also, our income and expenses have remained level, but our givings to other funds and projects has been significant. Further, the church is clearly meeting its commitment to being a community partner. Thus, Grace United Church is not declining. In terms of growth, in 2013 Council will continue to cut expenditures where possible, and hopes to redirect givings from special funds and projects to the operating budget.

An individual strongly suggested that Grace United Church carry out a stewardship campaign targeting the Unified Budget (and the Mission & Service Fund).

An individual raised concern that Grace United Church is spending more money internally than it is giving externally in the form of outreach, particularly when considering that the M&S percentage budgeted was only seven and a half percent (7.5%). A target of fifty percent (50%) was suggested.

Others suggested that not all outreach is captured by the budget. For example, donations of physical goods are often made on behalf of Grace United Church.

Motion: That the 2013 Budget [endorsed by Council, as printed in the 2012 Annual Report, with total expenditures of \$428,700.00] be approved.

Pauline Henderson-Ferguson/Clint Sykes. Carried.

## c) 2012 Financial Review

Since Gord Walkling was a member of the review team, he assigned Iris Murtha (Past Chair) to chair this portion of the meeting. Gord Walkling presented the 2012 Financial Review for information. He stated the following:

It is the opinion of the reviewers that the bookkeeping and other financial procedures carried out by the Financial Team at Grace United Church in 2012 were appropriate and were being complied with. It is our opinion that there are reasonable safeguards in place in order to minimize the risk of error or fraud. Those involved, particularly the Treasurer, Assistant Treasurer and Admin support are commended for their excellent work.

A question was raised regarding which funds were reviewed by the

committee. Bob Newman explained that some funds are administered separately, and would not form part of the review (ex. AOTS, UCW, etc.). Also, Gord Walkling explained that specific documents, such as charitable receipts issued or individual staff payroll records, were not reviewed due to confidentially. However, when possible, the cumulative amounts handled were reviewed.

A question was raised regarding the process the Financial Review Committee would follow in the event a discrepancy was discovered. Gord Walkling explained that, as per the position description described in Appendix 2.2 of the Grace United Church Constitution, the committee is to "pursue discrepancies in procedures, records and minutes until satisfied." The process is to consult with the treasurer, then the Finance Committee, then Grace Council (with irregularities reported in writing) and, finally, the congregation.

Bob Newman explained that he has investigated having an external audit performed, rather than an internal review. The cost estimate for such an audit would be approximately two thousand dollars (\$2,000). Additionally, the auditor would not be able to provide a certification, because the church handles cash (ex. cash offering donations).

## 7. Nominating Committee Report

It was explained that the intention of Council is for the Financial Review Committee membership to consist of three members, each serving a three year term. By having two experienced members and one trainee, the membership would rotate each year.

Motion: That Gord Walkling, Maureen Grimwood and Laura Black be appointed as the 2013 Financial Review Committee.

Iris Murtha/Bob Newman. Carried.

Iris Murtha listed the slate of officers for 2013: Chair, Joanna Catterson; Vice Chair, George Pfaff; Past Chair, Gord Walkling; Secretary, Christopher Cooke; Treasurer, Paul Cooper; Presbytery Representatives and Delegates to Conference, Marg Cameron and Madeline McCaw.

Motion: That nominations be closed. George Vero/John Robertson. Carried.

Motion: That the slate of officers [as listed by Iris Murtha] be approved.

#### **LEADERSHIP REPORTS**

## Message from Pat

Wherever my church travels lead there are formal and informal discussions, panels, workshops, seminars, task groups, and articles on the subject of the future of the church. There seems to be great anxiety in the air about the viability of the church: our church at Indian and Cathcart, the United Church of Canada, and *the* Church. We are beyond the days of debating whether or not Christendom is in decline. The discussion has turned to forecasting what is to come and how to survive.

Douglas John Hall (the great Canadian United Church theologian), in his book "The End of Christendom and the Future of Christianity" reminds us that the church took a dangerous turn in the fourth century when it wed itself to the powerful Constantinian state. Expansion was its goal. Proximity to power was its strategy. The vision was of a world won over by the Christian church.

Even to this day, and at the micro level, "church growth" is a common phrase. We even comb the pages of this report looking for signs of success measured by healthy programs and givings, the metric that hints at our future, eases anxiety, and lets us believe that perhaps we are still a force, at least here in Sarnia. But expansion and power, as Hall warns, was a motivation of yesterday's imperial Christendom.

Christendom tried large. Jesus called for small. Remember the mustard seed.

The 2013 Grace narrative includes dimensions that are difficult to capture in these pages. Gospel is enacted by the people of Grace in humble ways, motivated by nothing more than care for another. This report cannot fully qualify our connection to Community Living, Inn of the Good Shepherd, or Bridges Out Of Poverty. Our gospel narrative includes stories of teens affirmed and nurtured, even saved by shared conversation with a caring adult who join them in a difficult moment, and the spirit of healing in a pastoral visit with a family that has lost a loved one or dealing with the difficulty of marital fracture.

As we comb these pages let us look for signs of proximity to the powerless. Listen for conversations and accommodations motivated by the need of another rather than church growth. And let us agree that this is our election.

Thank you for allowing me to serve with you.

## Message from Sue...

We have a great family ritual for New Year's Day. Everyone in the family shares their top five experiences of the year that has just ended. This year my entire list was comprised of things that I did on sabbatical; my visit to the Greenbelt festival in England, my side trip to Northern Ireland, my venture to Montreal and my friend Scott's church, my trip to Chicago where I visited the Obama's former church home and our family's exciting game of croquet on the beach of Shediac.

Once again I realized how blessed I was to have had a sabbatical and how very grateful I am to the Grace community for offering this gift of rest, reflection and renewal. But the other important gift of sabbatical was one that contributed significantly to the ease of my return. When I was on sabbatical I had the opportunity to visit many churches, to engage in ministry opportunities and to talk with many colleagues who work across this country and around the globe. All of these experiences helped me to realize what an amazing and wonderful community of faith we have in Grace!

Of course we have challenges – most of which are not so different than those that many churches and nonprofit organizations face. There are unpredictable revenues, shifting demographics, the occasional personality conflict, or heated debate. There are issues with the ebb and flow of programs and volunteers to run them. But we also have so many great things that are unique in this time of national church decline. We have a vibrant collection of children and youth, many new people who not only attend but offer their support to programs and events, we have folks who love to have fun together but who are not afraid to roll up their sleeves and get down to the hard work of doing justice and spreading compassion, love and healing into this world.

A few weeks before the end of my sabbatical people in my life started conversations with notable tones of concern in their voices, "What's it going to be like when you go back to church? How are you going to get used to all the demands of your job and all the driving back and forth?" Soon their questions wove doubts into the fabric of my own thoughts. "Am I the right person to be at Grace? Is it time for me to leave? Maybe I can't re-adjust to the requirements of ministry?"

But then, by chance, I met with someone who was dreading a return she was about to make to a job she hated. I walked away from our discussion and suddenly my fears evaporated and were replaced by the solidity of this thought, "Wow! I'm going back to a place I love, to people I love, and to work that I love! How great is that?!"

Thanks to all of you for the many gifts that you bring to our church family and to my wonderful colleagues Brad, Curtis, Glenn, Lori and Pat who bring an ocean of talents and an endless stream of laughter and love to all the work we do together! I feel so deeply grateful that God has put us all together for this exciting work of ministry and mission. May God continue to give us the resources to grow into a future that is already securely planted upon the foundation of God's grace, faithfulness and love!

# Message from Brad...

Grace's mission strategy – to be an inclusive, intergenerational, and active community partner – continued to guide my 2013 goals. I thank the congregation, pastoral team and staff for your ongoing willingness to explore and experiment.

**Inclusive.** In response to the Accessibility for Ontarians with Disabilities Act (AODA), Congregational Care and Growth Committee established an ad hoc Accessibilities Committee. After an extensive assessment and congregational survey, the committee identified building and program areas needing improvement. This work is ongoing, and I thank the committee members for their patient work. I ask that the congregation keep this important work in mind as building projects come forward.

**Intergenerational.** During Susan Browning's sabbatical, I experimented with ways to involve children and youth in worship leadership. We revised the order of service to allow a Junior Leader to lead the Lord's Prayer, Passing of the Peace, calling forward the children for the Swell, and co-presiding at Communion. Some of the Jr. Leaders gathered with the choir for prayer prior to processing into the sanctuary. Thank you to Lori for recruiting our Jr. Leaders.

**Community Partner**. A pub may seem like a strange community partner, but in 2013 we experimented with some fun events at Two Amigos: a pool tournament and Beer & Carols. Typical church partnerships include social service agencies, other faith communities, and volunteer organizations. We know how to partner with these organizations because they are a regular part of our lives – we understand how they work and how to identify a common mission.

The pool tournament arose from the question, "Where are Grace's members doing ministry that Grace is reluctant to go?" I was inspired early in 2013 to see a couple of our Grace members meet weekly at Two Amigos to support a friend dying of cancer. It was a beautiful thing to observe. Two Amigos was a place for a ministry of care.

Through the summer, I published a ten chapter short story sermon to explore the relationship between parish and pub. It is a different kind of partnership, and I wondered how a pub would respond to a request to hold a church event. (Perhaps more than I wondered how Grace would respond to a pub event.) The experiment began with the pool tournament in early August, which was

well attended by participants and spectators (and won by Iris Murtha, I add for the record).

When Pat returned from his Greenbelt trip in late August, we debriefed his experience of Beer and Hymns. From that conversation was born our experiment with Beer and Carols at Two Amigos. Again, I wondered how the pub would respond to the request more than how Grace would respond. I was pleased to see over 100 participants, including other congregations, invited friends, and unsuspecting patrons – all singing about Christ's birth in a public space where the church is reluctant to go.

**Door into the Community.** For the past few years, the "Already Mission" idea has celebrated the ways the people of Grace serve the community. As 2014 unfolds, I look forward to developing this theme further to explore how Grace serves as a doorway into the Sarnia community. I've started this exploration through my approach to Sunday morning announcements.

Thank you for your ongoing support for Grace's ministries in our community and beyond. Thank you to Curtis, Glenn, Lori, Pat, and SueB, for partnering with me in this ministry.

# Message from the Outgoing Chair of Council...

When I took on the role of Chair of Council I decided not to establish a theme for my tenure as I felt that Grace already had a strong vision and mission under the banner of being "Inclusive, Intergenerational, and a Community Partner" and we didn't require another layer of language to cloud that message. I am really attracted to that vision and the "Already Mission" concepts that this church espouses and I thought that it was important that Council upheld these ideas as we made decisions and communicated to the congregation over the year.

After a year in the position I continue to believe that this statement sums up very well what we as a congregation believe and do on a daily basis. I am constantly amazed by the dedication and passion people have for this church and how it affects the lives of so many. As I look around at the people who surround me every week I see how they live out the challenge of being "Inclusive, Intergenerational, and a Community Partner" and those are just the ones whose stories I know!

I see inclusivity in action every week as we strive to provide people with what they need to access our services, whether it is through listening devices, the provision of a nursery and a pager system, large print bulletins, help with wheelchairs/walkers, gluten free options for Communion, and services taped for those who can't attend in person. I am sure there are countless other acts of inclusion that happen on a day to day basis that most of us aren't even aware of.

Grace seems to do "Intergenerational" very well in the sense of not only having opportunities for all ages but opportunities between ages. I have always loved the fact that our children bless us and we bless them in return as they leave for junior worship. As a mentor for the Confirmation class I appreciate the intentional way that activities are structured so that learning occurs and relationships are built between teens and caring adults. There is research around resiliency in children and teens that indicates that having caring adults in their lives is an important safeguard for positive mental health. As the mother of a teen just launching into the world, I truly appreciate this aspect of Grace's ministry. From music selections to events to groups, Grace does an excellent job of supporting and welcoming those of all ages.

Outreach is dear to the hearts of many in our congregation and can be defined in a number of different ways. For some it is faithful givings and support for the Mission and Service Fund, for others it is serving on boards of charitable and community organizations. For still others it is time and labour given to support a cause or leadership in a group. For some the outreach is close to home in our local community and for others it is around the world. In whatever way you choose to affect the world positively, you are embodying Grace's mission to be a Community Partner. Grace has formal relationships with many community partners such as the Inn of the Good Shepherd, Rayjon, and Community Living and through the congregation has an impact on many more. So many of Grace's members are directly involved in mission through these and many other community and wider world pursuits and I am honoured to belong to an organization that wants to support its members as they act as God's light in the world.

The past two years as Vice-Chair and Chair of Council have been times of learning for me. I have gained a greater appreciation of all the work that happens to make this congregation a vibrant, caring, and thriving place where people of all types can come together to worship, celebrate, and act out their faith and our collective mission. We are blessed with a talented, dynamic, and wise ministerial team, a dedicated staff, and a network of volunteers. I have witnessed the passion and concern of people for this community of faith as they make decisions and struggle with the realities of ensuring that we continue to be a place that truly is "Inclusive, Intergenerational, and a Community Partner." May God bless us as we continue in that work.

#### **WORSHIP MINISTRIES**

#### **WORSHIP COMMITTEE**

The committee is responsible for reviewing and approving the various requests for use of the sanctuary and chapel for "non-routine" worship and non-worship events that serve our congregation and/or our community. In addition to this the committee sponsors projects to improve these facilities.

Communion is an important event in the Worship calendar. In 2013, the Worship Committee decided that it would be appropriate to include gluten-free wafers as options for the communion services. The response from the members of the congregation regarding the inclusion of the gluten-free option was positive. The Worship Committee acknowledges the efforts of all those who serve communion during our services and to Joyce Rawson and her team who prepare the elements.

In 2013, Sue Browning completed a sabbatical leave during the summer. During Sue's leave, ministerial coverage was provided by Gord Walkling, Rev. Dr. Bob Gibson, and Rev. Sally Shaw.

This year we have made a concerted effort to have more involvement of children and youth in our worship services. In Lent this year, youth in our congregation taught us spiritual practices each week during our Lenten ritual. In the summer Brad had a child or youth share in the liturgy with him each week. Throughout the season of Advent, children and youth in our congregation painted pictures of hope, joy, peace and love and led us in the Advent candle lighting. They invited us to draw our own reflections on these gifts and each week our pictures were collected and put up on boards in the narthex for the season of Advent.

On Advent 3 this year, we replaced the traditional Children's Christmas musical with a worship service called "Ode to Joy". The service featured many musical talents like Valerie Schmidt and the Nightingale Chorus, the Celebration Singers, the Grace Choir, Andris Evans and Monica Morrison, Gabrielle Drapeau, and Piper's Pen. In the centre of the service was a Christmas cantata performed by the children and conducted by Cecily Chiles and Glenn Parsons and narrated by Noah Cattran and Sue. This featured the story of Jesus' birth and how it has inspired many people and cultures throughout the ages including the Aboriginal Huron tribe in Canada.

On December 29 Celine McGarvey came back to Grace to preach a sermon and also lead the worship service, sharing her experiences of working at Annunciation House in Texas this year. These are just some of the ways that our youth and children have enriched our worship experiences.

Music is an important element of Sunday morning worship services at Grace and continues to be offered through several diverse avenues. The Grace

Choir, Celebration Singers and the Pipers' Pen are the primary providers of the musical diversity. ## **GRACE CHOIR**



#### **OUTREACH MINISTRIES**

## **OUTREACH COMMITTEE**

The Outreach Committee has a mandate to engage the Grace United congregation in;

- a) local outreach activities (usually in sponsorship with a local organization)
- b) providing a focal point for the United Church Mission and Service Fund (M&S), and
- c) communicating other international initiatives (including urgent disaster relief response requests)

In 2013, Outreach activities included organizing soup luncheons, supporting special M&S appeals, helping prepare and serve a monthly meal at the Inn of the Good Shepherd, hosting dinners to support Circles (Bridges-out-of-Poverty), supporting the Habitat for Humanity build, partnering with Brigden United Church to sponsor a Canadian Foodgrains Bank 'Grow' project, and continuing our partnership with Community Living.

**Community Living** continues to occupy and maintain the Grace United Church Manse as a residence and respite location for their clients in addition to holding regular dance events in the gymnasium. We are indeed fortunate to continue to benefit from this ongoing association.

In 2013, Sarnia continued to expand the Circles (Bridges Out of Poverty) initiative. This is a unique and challenging undertaking with the ultimate goal of breaking the cycle of continuing poverty in our community. David Motherwell has become a 'Circle Ally' and provides a focal point and source of information for Grace and the Outreach Committee. Measurable progress (exiting social assistance programs, increasing employment earnings and obtaining additional educational qualifications) continued to be made in 2013. Sarnia is now the 'National Training Site for Circles in Canada" and provides leadership as additional communities startup their own programs. As a committee, and

with participation from other members of the congregation, Grace hosted supper meals at the regular 'Circle' meetings to show our support. As additional circles are established, we hope that members of the congregation will decide to get involved in this significant outreach activity and add to the amazing support being provided from all sectors of Sarnia-Lambton.

In 2013, Grace continued our partnership with Brigden United on a **Canadian Foodgrains Bank "Grow"** project. The soybean crop was harvested in the fall. Financial results are still to come; however, plans are already in-place for another project in 2014. Our soup luncheon donations assisted with funding for the project led by two local farmers. In addition, Grace hosted a CFGB regional meeting in November. Although inclement weather impacted the program, a good information exchange was held to share progress and activities.

In November of 2013, the **Habitat for Humanity** Euphemia Street build (sponsored by the United Churches of Lambton Presbytery and done in partnership with Community Living) was completed. Grace provided funding (through soup luncheons) and also provided meals and refreshments for the Habitat workers over the duration of the build. As noted in the HFH year-end newsletter, "now four acutely disabled young adults have the purpose-built, fully accessible home that they both need and deserve".

You, the Grace congregation, were very generous in 2013 maintaining our support for the **United Church Mission and Service Fund.** In addition to the support provided through our operating budget, special donations were received at Easter, Thanksgiving and Christmas. Following the catastrophic impact of Typhoon Haiyan on the Philippines, significant funds were donated to provide emergency and ongoing relief (to be matched by the Canadian Federal Government).

The congregation was very generous in supporting the **Soup Luncheons** held in 2013 – seven were held during the year. The following organizations benefited from our soup luncheons in 2013:

#### **TEACHING MINISTRIES**

## CHRISTIAN DEVELOPMENT COMMITTEE

We are continuously visioning and dreaming, looking for creative ways to meet our mandate under the current financial constraints. - The Shrove Tuesday pancake supper was a huge success in terms of volunteers and number of attendees. The money raised went toward funding the summer student placement.
- We applied for and received an HRDC Grant that funded the second summer student placement responsible for the campfire program.
- Summer Campfires continue to be a successful program sponsored by the CD Committee. They offered opportunities for our young leaders to hone their skills and deliver an exciting program for children and their families. This program continues to grow and attract more community members who look forward to it each Friday in July. # GIRL GUIDES OF CANADA

All units participated in the Grace Fall Fair. Guides ran the tea and muffin room which raised \$205. Brownies and Sparks raised \$160.00 with their sales of cookies and brownies.

# Membership

This year our group has 22 Beavers/8 Beaver leaders, 17 Cubs/4 Cub leaders, 10 Scouts/3 Scout leaders, 5 Venturers/2 Venturer advisors for a total of 54 youth members and 17 leaders.

Glenn Kilner continues as our Group Committee Chair and has moved up to the Scout section. The remainder of our executive remains unchanged from last year: Dave Aldrey, Treasurer; Norma Shortt, Fundraising: Julie Drope, Secretary; Glenn Kilner, Scouts; Tony Westlaken, Venturers; Meghan Fraser, Beavers; Rob Tower, Cubs; Jeff English, Popcorn Co-ordinator.

The greatest membership challenge for the 32<sup>nd</sup> is finding leaders for our programs. We have a core of leaders who have been with us for years, mainly with Scouts and Venturers. Each year we turn away Beaver aged children because we lack leaders. This year was an exceptional year, as our Cub pack almost folded due to lack of leaders. Thankfully a few parents stepped forward at the urging of Glenn. The Point Edward Cub pack folded last year and with the additional leaders we were able to accommodate these children to our section. Point Edward's Scout troop folded at the end of 2013, so we will get one new Scout and a Scout leader as well. We are always looking for potential leaders!

One of our long-time leaders, Steve Young, passed away in October. Steve started with the Beaver Colony over 10 years ago with his two sons, and moved up to Cubs and Scouts along with his boys. He was an integral part of the two Scout trips to Haliburton Scout Reserve and was a positive influence to many of our youth. We have established a trophy for the Cub Car Races in his memory. Steve is missed by many.

#### **Activities**

- Our annual Baden-Powell dinner in February is held as part of Baden-Powell week activities. The sections prepare skits for an appreciative audience of parents and siblings. The potluck dinner is a hit with kids of all ages.
- The annual Hike for Hunger for the Inn of the Good Shepherd was held in mid-February. Cubs, Scouts and Venturers collected canned goods, with the Cubs winning the contest for most pounds collected. They got a pizza party for their efforts.
- All four groups attended various camps at Camp Attawandron throughout the year, including the winter Klondyke Camp and spring Can-Am camp.
- Our group participated in the Annual Kinsmen Christmas Parade in December, entering a float with a "Christmas Wonderland" theme.
- Grace United held the Tri-Shores Award Ceremony in the spring to award the Chief Scout and Queen's Venturer Award. Over 450 people attended this event.
- The Venturers have volunteered at the Inn of the Good Shepherd twice so far and plan to make this a regular event.
- In November, the Cubs and Scouts participated in Trees For Canada, planting trees at Heritage Park. The trees were planted in the shape of a cross in remembrance of all soldiers who gave their lives during the various wars. Next year a plaque will be placed on a tree in honour of a soldier who gave his life.
- We purchased a new aluminum racing track for the cub and scout races, replacing our worn-out wooden track. Grace 32<sup>nd</sup> will be holding the regional races in February 2014 in the Grace gym. The Beaver Buggies

will race in Room 1 on the same day (run by St. Bart's 23<sup>rd</sup>). We expect 300 people to attend.

## Fundraising

- All sections participated in October's city-wide Apple Day fundraiser. For the first time Apple Day was moved from the weekend before Thanksgiving to the weekend following. Beavers each had one 2 hour shift, and Cubs and Scouts contributed 4 hours to this important fundraiser. The Ventures helped with apple distribution and money counting. All of the money raised is used by the sections for activities and camps.
- The annual spring flower and poinsettia sales were once again very successful. The Group Committee is very appreciative of the continuing relationship with Praill's Greenhouses. Mr. Praill continues to be a strong supporter of the 32nd Sarnia Group. We appreciate the support of the Grace community for our various fundraisers.
- Our group has received grants from Imperial Oil and Bluewater Power through their corporate employee volunteer programs. These funds will be used to obtain equipment and provide leader support. Our group also received a grant from ChemFab to purchase materials for the Christmas Parade float and the truck and float was donated by Woody Woudstra. Pat Morrison donated his time to set up his sound system for Christmas music on the float.

#### Ron Klusmeier

Grace United was pleased to host Ron Klusmeier's "Tour of a Lifetime" on Sunday, February 3, 2013. Similar concerts were held in over 200 communities throughout North America. This retirement tour included afternoon music workshops and concluded with an evening concert.

Unfortunately, the bleak weather which moved in the weekend of the concert kept the attendance and participation down. Ron, in spite of the lower numbers presented an outstanding concert.

Twenty five percent of the funds that were raised were contributed directly to the Canadian Foodgrains Bank.

#### **Adullam Summer Choir Concert**

On Thursday, August 23, 2013 the Proclamation & Special Events Committee of Grace United Church was once again pleased to support and host the Adullam Choir Camp Concert. This anticipated annual summer evening of music has been steadily growing in popularity.

Thanks is once again extended to Yvonne Vanderbeld, and Bill Yates for continuing to organize and promote this marvelous music ministry. They in turn wish to show their appreciation to John Scott and Curtis Dixon for their efforts in setting up the sanctuary in preparation for the concert.

# Spring Fair and Art Sale

This year it was decided to remove the attic treasures from the event and set up another fundraiser utilizing the parking lot as well as the building. Plant sales were moved into the gym to give them a more prominent location. Special thanks to John and Ellen Robertson and Chris and Ian McGuiness for organizing and selling the plants. to sell garage sale items. BBQ and music was provided by the Face of Grace Relay for Life Team, giving them an opportunity to fundraise outside of Grace. This event has the potential to grow with more vendors, live music and possibility of more revenue with an earlier start and serving/selling breakfast as well as lunch.

## **Ladies Day Out**

This new event was held twice, in February and June with a third September date cancelled as practitioners were not available. This event attracted new people to Grace in the form of practitioners, vendors and participants. Special thanks to Ruth Ann Levak and Tina Levak for all their assistance with Ladies Day Out. Without their assistance, the events would not have happened. While the events raised close to \$1500.00, the number of volunteers needed exceeds the number available to assist. Future Ladies Day Out events need to be reviewed before committing to continuing.

## **Last Chance Christmas Sale**

This was the event's third year and despite the snowy weather, feedback was positive. Vendors felt the event was well advertised, well organized and there was a good variety of vendors. Many new vendors participating sold handmade items. The addition of the tea room was well received and enjoyed by most of those who attended the sale. The silent auction did very well, with most of the items donated by the vendors. Warm cookies made by Ken Ferguson and served by Paige Ferguson were greatly appreciated and added to the festive atmosphere.

#### Fall Fair

Lawn signs advertising the event and holding the event from 9:00am to 1:00pm were some of the changes made to the Fall Fair. Book sales and silent auction were moved to give them more space to set up and display items. Thanks to Trish White and Lorna Cooper for their leadership in these areas. Horse and wagon rides ran from 10:00am to 12:00pm and were enjoyed despite the rain. Children's activities were moved indoors and Thomas Valade adapted the games as needed. Thanks to Maggie and Bob Rochon for their assistance with all the planning, Bev Walkling for the advertising and involving the Guiding Groups, AOTS for the BBQ, Adult Fellowship for the bake table, Edna Dent and Diane Werezak for the Freezer Foods and the Face of Grace Relay for Life Team for the Pizza Sales.

### PLANNING COMMITTEE

## **Congregational Consultations**

The Planning Committee strives to keep aware of, and challenge Grace United Church to respond to changes in direction occurring in the church at large and to consider where we are going as a faith community. This year, the Planning Committee held Congregational Consultations which asked participants the following questions:

What brought you to Grace?
When did you feel you belonged?

How do you see Grace living into being Intergenerational, Inclusive and a Community Partner?

We met with 6-8 people each session and enjoyed discussion, snacks and fellowship. Many commented that it was a rewarding exercise and was also a nice chance to better acquaint ourselves with the people we see each Sunday.

We plan on hosting another session this winter. Please contact one of the committee members if you are interested in attending.

## Stewardship Education

The Planning Committee is also responsible for developing and implementing an ongoing financial stewardship strategy. Our 2013 "Stewardship Roadmap" builds on previous survey findings that there are multiple motivations for giving at Grace:

- when Grace adds value to personal or family life
- to support Grace's reputation for outreach
- to support special projects
- commitment to tithing or percentage giving
- when provided information about financial picture

In 2013, the Planning Committee developed a Givings Guide, available from the office and distributed to every household, describing average per household contributions and benefits. The Planning Committee provided consultative support for the Fundscrip initiative, which relates to our committee's call for alternative revenue strategies. The Planning Committee also supported pastoral team initiatives for stewardship education in the pulpit and Grace Notes.

# **Planned Giving**

In 2013 we finalized an agreement with the Sarnia Community Foundation to facilitate our planned giving strategy. A Planned Giving Guide is available from the office for anyone considering a bequest or any large financial gift to Grace United.

#### **Prioritization Process**

Planning continues to receive Project Proposal forms. The committee scores each proposal and forwards recommendations to Council. The Project Proposal form is to be used by any established and recognized committee, organization, small group, and individual members of Grace United Church who wish Grace Council to consider undertaking a project that falls outside of, or apart from, the normal and routine operating expenses of the programs or ministry provisions approved annually by the Council in its operating budget. Forms can be found on the Grace website or through the church office.

### **FINANCE COMMITTEE**

Financially, 2013 followed the annual trend of facing a very large deficit starting in the summer with generous donations starting in October through December reducing the deficit but still falling short of achieving the overall budget closure at year's end (deficit for 2013 was \$18,000). The deficit was covered by using part of the Reserve Fund and the remainder of the Legacy Fund (contingent upon congregational approval). Total costs were below budget as committees found new, innovative ways to achieve their goals. In addition, positive results from Special Events – including the Spring and Fall Fairs and Last Chance Christmas Sale – were a key factor on the revenue side. 2013 was expected to be a challenging year with costs that are imposed externally resulting in a 5% increase in budget versus 2012. (the Councilapproved budget for 2013 was for a deficit of \$10,000).

Financially, the congregation also made significant contributions to Outreach initiatives (see the summary in the Annual Report) as well as to funds to support specific ministries. Various funds are available for directed donations (examples are the Capital Replacement Fund, Memorial Fund, Office Equipment Fund) for those members of the congregation who prefer to support these initiatives. The Property Committee, as an example, have a number of projects in the queue that would sustain and improve the building we all enjoy and that is heavily used by many community groups.

2014 will again be a challenging year. However, committees have accepted challenging budget targets which will keep costs at a 0% increase versus 2013. Continuing to support and expand special events and success of new fund-raising programs (like FUNDSCRIP) will enable us to achieve our financial goals. Your support for the special events that provide financial support for the church as well as the fellowship of working with other members

of the Grace community is appreciated. In addition, our Planning Committee is always searching for new ways of raising money so kudos to them.

Members of the 2014 Finance Committee will be: Helen West, Neil Pole, Ian McGuiness, Marv Bildfell, Peg Dawkins, Bob Newman, Paul Cooper, and the Pastoral Team *(ex offcio).* We are in need of new members and a new chairperson.

Finally, thank you to all members of the congregation who have contributed financially to the Unified Budget, various funds, and outreach causes. Without your generosity, Grace could not exist.
